Understanding Tax & Compliance for Your LLC



What You Need to File for Taxes

The IRS has different tax filing requirements based on your LLC structure and income status. Here's a breakdown:

-  **No Income LLC:** Even if your LLC has no earnings, you may still have to file certain tax forms to stay compliant.
-  **Single-Member LLC:** Taxed as a disregarded entity by default, meaning you file profits/losses on your personal tax return (Form 1040 + Schedule C).
-  **Multi-Member LLC:** Taxed as a partnership by default. Must file Form 1065 and provide K-1s to members.
-  **LLC Electing as an S-Corp:** Must file Form 1120-S and pay yourself a reasonable salary.
-  **LLC Electing as a C-Corp:** Must file Form 1120 and may face double taxation.



BOI Report (Beneficial Ownership Information)

Starting January 1, 2024, the BOI report is mandatory for most LLCs and corporations.

- Required for all new and existing LLCs.
- Must be filed with FinCEN to disclose company ownership.
- Deadlines:
 - LLCs formed before 2024 → Must file by January 1, 2025.
 - LLCs formed in 2024 and beyond → Must file within 90 days of formation.




Important Tax Deadlines

- March 15: Multi-member LLCs & S-Corps (Form 1065 & 1120-S)
- April 15: Single-member LLCs & C-Corps (Form 1040 + Schedule C & 1120)
- January 1, 2025: BOI Report Deadline for existing LLCs
